A special called meeting of the Board of Commissioners was held at the District Office in the Board Room, 3335 Wade Hampton Blvd., Taylors, South Carolina at 9:00 am.

The workshop/meeting was called to order by Chairman Rea at 9:00 am.

Chairman Rea recognized Mr. Scott Taylor to present a draft of the FY 2016 budget. The Department Heads discussed the pros and cons of their budgets. Discussion was made for millage amounts for FY 2016. There was an in-depth discussion for the upcoming fiscal year's budget. Discussion was made to hold a Public Hearing to present the FY 2016 budget on June 16, 2015 immediately following the Regular Monthly Meeting at 4:30 pm.

Vice Chairman/Secretary Wavle moved to hold a Public Hearing on June 16, 2015 immediately following our regular Commission Meeting at 4:30 pm to discuss the FY 2016 proposed budget. The proposed percentage increase in the millage rate between FY 2015 to FY 2016 for the Fire Department is 3.36% and for the Sewer Department is 3.03%. The FY 2015 tax millage rate for the Fire Department is 53.6 mils and the proposed tax millage rate for FY 2016 is 55.4 mils. The FY 2015 tax millage rate for the Sewer Department is 19.8 mils and the proposed tax millage rate for FY 2016 is 20.4 mils. Seconded by Treasurer Bowen, the motion carried unanimously.




